

Section 3 – External Auditor’s Report and Certificate 2024/25

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02) as issued by the NAO on behalf of the Comptroller and Auditor General. AGN 02 is available from the NAO website – <https://www.nao.org.uk/code-audit-practice/guidance-and-information-for-auditors/>

This authority is responsible for ensuring that its financial management is adequate and effective and that it has a sound system of internal control. The authority prepares an Annual Governance and Accountability Return in accordance with *Proper Practices* which:

- summarises the accounting records for the year ended 31 March 2025; and
- confirms and provides assurance on those matters that are relevant to our duties and responsibilities as external auditors.

2 External auditor’s limited assurance opinion 2024/25

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The smaller authority has not addressed the ‘except for’ matters raised by the external auditor when qualifying the prior year annual return. Section 2, Box 10 should have been amended to read £460,866 in the comparative column of this year’s AGAR.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year’s AGAR:

- The smaller authority did not have a fixed asset register as at 31 March 2025 and as a result the value included in Section 2, Box 9 is an estimate. A fixed asset register is being prepared and the smaller authority should restate Box 9 for 2024/25 when completing the 2025/26 AGAR to reflect the value of assets held as at 31 March 2025. This is consistent with the Internal Auditor’s response to Internal Control Objective H. This was also an ‘except for’ matter raised by the external auditor in the prior year and, therefore, the smaller authority has not addressed this when qualifying the prior year annual return as the figure in Section 2, Box 9 in the comparative column of this year’s AGAR has not been amended. Therefore, Section 1, Assertion 2 has been incorrectly completed.

Other matters not affecting our opinion which we draw to the attention of the authority:

In the completion of the Annual Internal Audit Report, and their detailed report, the internal auditor has drawn attention to weaknesses in relation to banking arrangements, reviewing procedures and financial regulations, and publishing information on the smaller authority’s website. The smaller authority must ensure that action is taken to address these areas of weakness in a timely manner.
