 - f) 25/01012/FUL - SUNRISE NURSERIES GRETTON FIELDS GRETTON - CONSTRUCTION OF A 20M X 40M OUTDOOR EQUESTRIAN RIDING ARENA (MENAGE) WITH ASSOCIATED DRAINAGE AND PERIMETER FENCING FOR PRIVATE EQUESTRIAN USE. **Not within WTC area.**

- i) 25/01035/LBC - 78 NORTH STREET, WINCHCOMBE - THE PROPOSALS COMPRISE THE REPLACEMENT OF TWO DILAPIDATED TIMBER WINDOWS TO THE REAR ELEVATION OF THE LISTED BUILDING. THE EXISTING WINDOWS ARE BEYOND ECONOMICAL REPAIR DUE TO ADVANCED DETERIORATION OF THE TIMBER. THE REPLACEMENT WINDOWS WILL BE TIMBER, OF MATCHING DESIGN, PROFILE, OPENING METHOD AND DIMENSIONS TO THOSE EXISTING ON THE PROPERTY AND WILL BE INSTALLED WITHIN THE EXISTING OPENINGS. NO ALTERATION TO THE SURROUNDING FABRIC, MASONRY, OR WINDOW OPENINGS IS PROPOSED. THE WORKS ARE LIMITED IN SCOPE AND CONFINED TO LIKE-FOR-LIKE REPLACEMENT, WITH NO EXTENSION, DEMOLITION, OR CHANGE TO THE ARCHITECTURAL CHARACTER OR SIGNIFICANCE OF THE LISTED BUILDING. **No objection.**
